Dear Secretary Bose:

Dominion Energy South Carolina, Inc. (DESC), as the holder of the current license for the Stevens Creek Hydroelectric Project (Stevens Creek Project) (FERC No. P-2535) herein electronically files with the Federal Energy Regulatory Commission (FERC or Commission) the Final License Application (FLA) for the relicensing of the Stevens Creek Project. The Stevens Creek Project is located in Edgefield and McCormick counties, South Carolina and Columbia County, Georgia, at the confluence of Stevens Creek and the Savannah River, approximately one mile upstream of the Augusta Diversion Dam¹. The current license, issued by the Commission to South Carolina Electric & Gas Company² on November 22, 1995, is set to expire on October 31, 2025.

DESC has prepared this FLA according to the requirements of the Commission's regulations at 18 CFR Section 4. Consultation was undertaken in accordance with the procedures outlined under FERC's Traditional Licensing Process (TLP) which was approved by FERC on July 16, 2020. DESC is providing electronic copies of the FLA to relevant resource agencies, tribes, nongovernmental organizations, and other potential interested parties included on the attached distribution list. The FLA will be available FERC's at the https://elibrary.ferc.gov/eLibrary/search (reference docket number P-2535) and on the Steven Creek Project's relicensing website at www.stevenscreekrelicense.com. Additional electronic copies of the FLA are also available by request to Amy Bresnahan at the email address below.

Hard copies of the filing are available for inspection at the Kleinschmidt Associates office at 204 Caughman Farm Lane, Suite 301, Lexington, South Carolina, 29072. The FLA is also being twice noticed in a newspaper of general circulation within the counties in which the Project is located. Proof of publication will be provided to the Commission upon receipt.
