Request for Determination of Consistency or Non-Applicability with South Carolina Coastal Zone Consistency Division, Pursuant to Coastal Zone

Management Act

Stevens Creek Hydroelectric Project (FERC No. P-2535)

Dear Mr. Stout:

Dominion Energy South Carolina, Inc. (DESC) is the Licensee for the 17.3 MW Stevens Creek Hydroelectric Project (Project; FERC No. 2535), located in Edgefield and McCormick counties, South Carolina and Columbia County, Georgia, at the confluence of the Stevens Creek and the Savannah River, approximately one mile upstream of the Augusta Diversion Dam¹. DESC is currently in the process of applying for a new federal operating permit ("license") for the Project from the Federal Energy Regulatory Commission (FERC) in accordance with their regulations under 18 CFR Part 5. The existing license for the Project is due to expire on October 31, 2025.

Section 307(c)(3) of the Coastal Zone Management Act (CZMA) requires that all federally licensed and permitted activities be consistent with approved state Coastal Zone Management Programs. The Office of Ocean and Coastal Resource Management (OCRM) has direct permitting authority over the "critical areas" of the coast, defined as coastal waters, tidelands, and beach/dune systems. The OCRM also has indirect management authority of coastal resources throughout the eight coastal counties, defined as the

"coastal zone." It is our understanding that South Carolina's coastal zone consists of coastal waters and submerged bottom seaward to the State's jurisdictional limits, as well as the lands and waters of the eight coastal counties, including Horry, Georgetown, Berkely, Charleston, Dorchester, Colleton, Beaufort, and Jasper (Policies and Procedures of the South Carolina Coastal Management Program, updates July 1995).

Given this description, it appears the Project is well outside of the South Carolina coastal zone, and that continued Project operations would subsequently *not affect* South Carolina's coastal zone. As such, Kleinschmidt Associates, on behalf of DESC, is herein requesting OCRM's concurrence on this matter.

Assistance programs and intergovernmental reviews <u>outside</u> of these eleven (11) counties are not subject to the CZMA provisions and do not require approval from Coastal Resources Division.

Coastal Barrier Resources Act (CRBA) areas do not extend outside these eleven (11) coastal counties and do not require approval from Coastal Resources Division.

Housing and Urban Development (HUD) federal assistance projects proposed <u>anywhere</u> within Georgia, including within the eleven (11) coastal counties, do not require approval from Coastal Resources Division.
